PERSONAL GUARANTEE / TERMS OF AGREEMENT

In consideration of MAKI CORP., MAKI BUILDING CENTERS, INC., SPECIALTY WHOLESALE SUPPLY, GRAND RENTAL STATION and TOP NOTCH TRUSS CORP. (Hereinafter referred to as MAKI CORP.) extending credit to:

The undersigned hereby agree to the following terms:

1. To assure that the monthly statement is paid in full by the thirtieth of the month following the purchases. If the account is past due it will be closed to further purchases until paid in full.
2. In the event of default of the foregoing paragraph, I/We agree to pay the maximum legal rate of interest or service charge at the rate of and not exceeding 1 1/2% per month (18% annually) on all unpaid and delinquent accounts together with all costs thereof.
3. I authorize you to make an investigative consumer report and credit check for the purpose of MAKI CORP. extending credit to the above captioned business entity and understand that I may, upon reasonable request, within a reasonable period of time, receive additional information about the nature and scope of this investigative report.
4. I/We the undersigned personally, individually and unconditionally guarantee payment of whatever amount or amounts shall at any time be owing to MAKI CORP. and its above captioned subsidiaries on account of goods hereafter delivered, whether said indebtedness is in the form of notes, bills or open account.
5. This shall be an open and continuing personal guarantee and shall continue in force not with standing any change in the form of such indebtedness, or renewals or extension granted by you, without obtaining any consent thereto, and until expressly revoked by registered mail, return receipt requested from the undersigned to MAKI CORP. and any such revocation shall not in any manner affect my liability as to the indebtedness contracted prior thereto. Such revocation shall be effective prospectively only and this agreement shall remain in full force and effect with respect to all sums of money that are due and that become due from Customer as a result of transactions through and including the date 14 days after said revocation is received.
6. Notice of indebtedness and/or default in payment are hereby waived. The incorporation, merger, reorganization or sale of the above captioned business shall not operate as a termination of this guarantee.

In consideration of the credit extended in reliance on this agreement by MAKI CORP. and its above captioned subsidiaries, the undersigned jointly and severally personally, individually and unconditionally guarantee the payment of all accounts with MAKI CORP. and its above captioned subsidiaries incurred on behalf of the above captioned corporation, trust, limited partnership or other business entity together with all costs, expenses and attorney's fees incurred in its collection and enforcement.
8. Purchases and/or deliveries are authorized to be made without signatures.
9. I (We) agree that MAKI CORP. may, in accordance with applicable laws, replevin any materials supplied under this agreement
10. MAKI Corp. does not accept credit cards as a form of payment on your charge account.
11. I (We) agree to pay a restocking fee for all materials picked up at jobsites.
12. I (We) agree special orders are non refundable.
13. This agreement is a contract and shall be interpreted under the laws of Massachusetts and shall be affective immediately. Also, any disputes arising from this contract shall remain in the jurisdiction of Worcester County Courts. This agreement is binding upon the undersigned, his administrators, executors, heirs and assigns.
14. This personal guarantee shall be a continuing, absolute and unconditional guarantee and shall be enforceable by MAKI CORP. and any of its above captioned subsidiaries.
